Directions to Show Site

From South: Take I-77 or I-71 North toward Cleveland. Exit onto I-76 East toward Akron. Take I-80 toward Youngstown and NYC. Exit onto Bailey Road, turn right. Turn right onto Mahoning Avenue.

From East or West: Take Turnpike and Exit at Interchange 218. Take I-80 East to Bailey Road. Exit onto Bailey Road, turn right. Turn right onto Mahoning Avenue.

From North: Take 11 South to I-80 West. Exit on Bailey Road, turn left. Turn right onto Mahoning Avenue.

All: The YABTC building is located across from the blue water tower.

Set Up: You may set up crating beginning Thursday, October 6, 2016, from 5:30-7:00 p.m. On Friday, Saturday and Sunday, the facility will open at 7AM. **Crating will be marked. Each dog will be afforded a 3'x 4' space. The space will be marked on the floor. In order to have space for all exhibitors, ALL MUST OBSERVE THESE GUIDELINES. Also, do not leave your dogs in the building after show hours.**

Motels: The following motels accepted dogs at the time the premium was written. Each has a dog fee. Please check to be sure they still accept dogs when you make your reservation. They are located at I-80/Route 46, about 5 miles from the show site.

Please pick up after your dog(s) at the motel. **Failure to pick up both at the trial site and at the motel will mean expulsion from the show with no refund.** Please do not permit your dog to urinate on or in the building at the motel or the show site.

Food: Perri's breakfast and lunch buffet will be available all days and throughout each day. Your donations are greatly appreciated.

Vendors and Raffles: There will be no vendors at this trial.

Camping: There will be a designated area for campers.

Show Conditions: Indoors on rubber matting over a 5/8" foam sports cushion. Ring size is 100' x 85'. Contacts have a rubberized surface. The site is not air conditioned.

Limitations: There will be pick up bags available throughout the exterior of the site. The site is grass and woods.

Emergency Veterinary Service: Animal Emergency Clinic, 2680 W. Liberty Street (I-80 and Salt Springs Road, Youngstown, OH. 330-530-8387 (Call first.)

Measuring: A VMO will not be present at this trial.

Running Order: 4-26" each day. In each jump height, B dogs will run first, followed by A dogs, followed by preferred dogs unless conflicts change the running order.
