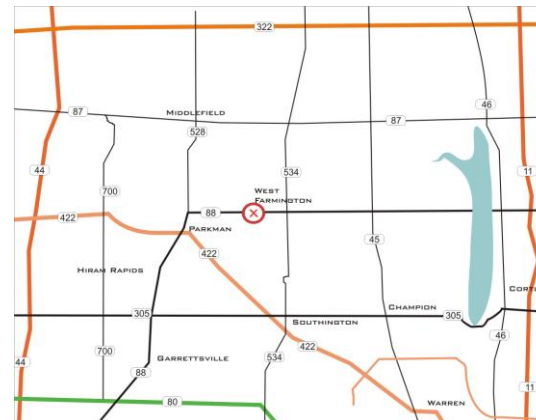
**Tracking Cover** for will be on vegetation surfaces typical on a farm.
