

Judging Schedule and Additional Information

This trial is one ring indoors on agility matting. The telephone number at Four Seasons is 330.427.6999; my cell phone, active on trial days, is 330-398 1051.

Please pick up refund checks the day of your run if you've pulled a dog or over paid.

Move ups will be accepted until 6 p.m. on June 2nd via email or postal mail, and there will be moveups available between trials in accordance with AKC regulations.

Measuring will be done while courses are being built. Novice dogs needing measuring should arrive before the stated briefing times.

There is sufficient crating if people are courteous and careful. If you are running excellent and leave early, please make room for the open and novice dogs and their crates. **Remember to pick up after your dog. People who don't will be asked to leave the trial. No money will be refunded.** Do not permit your dog to urinate on the buildings or concrete.

Directions to Four Seasons

For mapping programs or gps, use the address for the Washingtonville Huntington Bank—795 West Main Street, Washingtonville, OH 44490.

From South: Take I-77 or I-71 N toward Cleveland. Exit onto I-76 East toward Akron. Take I-80 toward Youngstown and NYC. Take 11 south. Exit on Route 46. Turn left (South) towards Columbiana. Turn right (west) at Route 14. Travel west on Route 14 for 4 miles. Turn left onto Painters Path, the graveled driveway to the show site. (Painters Path is immediately after Huntington Bank.)

From West: Take I-80 East to 11 South. Exit 11 at the Route 46 exit. Turn left (south) to Columbiana. Turn right onto Route 14. Travel west on Route 14 for 4 miles. Turn left onto Painters Path, the graveled driveway to the show site. (Painters Path is immediately after Huntington Bank.) **Or** take I-76 East to Route 14. Turn right onto 14 and proceed through Deerfield and Salem on 14. Show site will be on your right in Washingtonville, just before Huntington Bank.

From East: Take I-76 west toward Ohio. Exit at Route 7 (second exit in Ohio). Go south (toward North Lima) on 7. Turn right at Route 164. Take 164 South to Route 14. Turn right onto 14. Travel west on Route 14 for 4 miles. Turn left onto Painters Path, the graveled driveway to the show site. (Painters Path is immediately after Huntington Bank.)

From North: 11 South to Route 46 exit. Turn left toward Columbiana. Turn right onto Route 14. Travel west on Route 14 for 4 miles. Turn left onto Painters Path, the graveled driveway to the show site. (Painters Path is immediately after Huntington Bank.)
